

## STATUS OF REOPENING'S THIS WEEK



#### ► Associated Builders Case

- ▶EO 114 (prev. 97) Imposes MIOSHA criminal felony penalties
- ▶ EO Statutes permit only \$500 and Misdemeanor charges (90 days)
- ▶ Governor and AG argue general powers; ignore statutes
- ▶ Court of Claims rules for AB; Strikes criminal penalties

#### Signature Sotheby's Case

- Several businesses suing under Equal Protection, other theories
- DOJ has issued Statement of Interest three weeks ago
- ► Are the distinctions "arbitrary and irrational"?
- ▶ Governor filed 56 Page Motion To Dismiss June 5

#### SOUTH BAY UNITED PENTECOSTAL CHURCH v. NEWSOM

>25% Occupancy applied to churches but not host of others (S Ct. 5-4)
