MASK REQUIREMENTS UNDERSTANDING EXECUTIVE ORDER 2020-147 CONDUCTED BY GREATER ROCHESTER CHAMBER OF COMMERCE

- ▶ In Effect 7.10 and 7.13
- Cites Supportive Studies (pp 2-3)
- ► No Expiration Date
- Applies to Individuals and Businesses
- "Businesses" Should Be Applied Broadly
- Does Not Supersede Other Orders



#### EXECUTIVE ORDER 2020-147 ESSENTIALS



#### Must Wear A Mask:

- Indoor Public Space
- Outdoors: can't maintain 6 feet
- Public Transportation

# RESTRICTIONS ON INDIVIDUALS (¶1)

- ► Five Years Old or Younger
- Medical intolerance
- Necessity (several)
- Hearing Impaired Listener
- Public Safety
- ► Religious Service
- Giving a Speech to Audience




# INDIVIDUAL EXEMPTIONS (¶ 2)

- Business Must Be Open To Public
- Post Sign At Entrance
  - Legal Obligation to Wear Face Mask
  - MI LEO May Develop Required Signs
- Employees Not Mentioned
- "3 Questions" Not Specified
- ► Indoor Public Space (¶1)




## BUSINESS RESTRICTIONS (¶ 3)



#### ► To protect workers, shoppers, and the general public

- ► Activates Many Agencies State Police, Local Police
- ► Attorney General
- ► Public Health Departments
- Licensing Agencies Activated
  - ► Can Investigate Licensing
  - ► Liquor License Specifically Mentioned
- ►Local Enforcement
- Executive Order is Law Until Removed

ENFORCEMENT PROTOCOL AUTHORITIES



- Your Legal Duty Do Not Serve Non-Compliant Objector
- Develop a Compliance Policy
  - Model Policies are available
  - Not specifically required
- Avoid Physical Force
  - Common law (breach the peace)
  - Comparable to Landlord/Tenant
  - Call Police/Keep Distance

#### ENFORCEMENT PROTOCOL BUSINESSES

- Rescinds EO 2020-126; Effective through 8.10.2020
- Two Hours/Week Exclusive Service: Vulnerable Populations
- ► Host of COVID-19 Exposure Reduction Strategies (¶2)
  - Access facilities (employees and customers)
  - Checkout employee restrictions, masks
  - No Self Serve stations or free samples
- Notify Employees and Vendors of Positive Tests
- Food Law strict compliance
- Grocery and Convenience Stores; Takeout Restaurants

### EXECUTIVE ORDER 2020-149 FOOD SELLERS AND PHARMACIES

- Replaces Prior Order 2020-114
- Familiar Operating and Employee Protocols are Affirmed
- No Expiration Date
- Operating Protocols differ per business type
- ▶ Reaffirms 2020-36 (Cautious Objectors) remains effective

#### EXECUTIVE ORDER 2020-145 GENERAL OPERATING RESTRICTIONS

#### ► Acting Under 1945 Law

- ► Governor Can Issue Reasonable Orders
- ► Affected Area References
- ► May Also Impact Eligibility for Federal Disaster Assistance

### EXECUTIVE ORDER 2020-151 EMERGENCY DECLARATION
